

As of Friday, Aug 6, 2021, in accordance with the CDC guidelines and the JCC medical committee:

All members, guests, and staff are **required to wear MASKS** at **ALL TIMES** when on the Roth Family JCC & Federation Campus regardless of vaccination status. This includes indoor and outdoor facilities, parking lots, and the pool deck.

In order to keep everyone in our community safe the following policies are now in place:

- **Pick up for ECLC** will continue curbside front with required masks (same as last year) and you may text your respective teacher that you are ready for pick-up. *Teachers & Students will be entering/exiting ECLC side door*
- **Drop off for ECLC** will continue curbside front with required masks (same as last year). *Teachers & Students will be entering/exiting ECLC side door*
- Any further assistance may be obtained at the front Reception window.
- **Drop off and Pick Up for After School, and Enrichment Classes** Currently scheduled to resume September 9th 2021.
- Masks are required from the time you exit your car until you return to your car.

COVID POLICIES

- **Anyone who tests positive for the COVID-19 virus** may return following 10-Day Isolation and they are symptom-free without aid of medications.
- **Anyone who is directly exposed to the COVID-19 virus** may return following a 10-Day Quarantine from the Campus while remaining symptom-free without the aid of medication

OR

after a 7-Day Quarantine from the Campus while remaining symptom-free **AND** obtaining one (1) Negative COVID-19 test that occurred on Day-5 of exposure or later.

PLEASE NOTE...

Fitness Center

Masks are required in the Fitness Center. Our max capacity (including staff) will be 12 people at a time in the Fitness Center. If the fitness center is at capacity when you arrive, you may be asked to wait. Like many other fitness and retail locations, we want to make sure everyone is safe, and limiting the number of people in the fitness center at once helps us towards that goal.

Please make sure to wipe down after you move from one piece of equipment to another.

Group Exercise Classes

Masks are required. Please come prepared with your own fitness mat if the class requires one and a towel. Our max capacity (including staff) will be 12 people at a time in the Group Exercise class.

Deep Cleaning Schedule

- During the week, we will be closing the fitness center for a 30 minute deep cleaning at 11:30am and 4:30pm.
- On the weekends, we will be closing the fitness center for a 30 minute deep cleaning at 11:30am and 2:30pm.

Travel Policy

If you have traveled on any flight

(Domestic Destinations)

If you are NOT Vaccinated or NOT Fully Vaccinated, you may return upon:

10-Day QUARANTINE from Campus, Remaining SYMPTOM-FREE without the aid of medication

OR

Return Day-5 by Obtaining one (1) Negative COVID-19 test on day 5 while remaining SYMPTOM-FREE without the aid of medication.

NOTE: If you are FULLY VACCINATED, there is NO ISOLATION REQUIREMENT Upon Return

(International Destinations)

If you are NOT Vaccinated or NOT Fully Vaccinated, you may return upon:

10-Day QUARANTINE, Remaining SYMPTOM-FREE without the aid of medication
OR

Return Day 7 by Obtaining one (1) Negative COVID-19 test on Day 5 or later, and remaining SYMPTOM-FREE without the aid of medication.

****NOTE: If you are FULLY VACCINATED, upon your return you MUST quarantine 7 days - on Day 3 to 5 may obtain a Negative COVID-19 test for immediate return****

ALL Cruises

If you are NOT Vaccinated or NOT Fully Vaccinated, you may return upon:

10-Day QUARANTINE, Remaining SYMPTOM-FREE without the aid of medication
OR

Return Day 7 by Obtaining one (1) Negative COVID-19 test on Day 5 or later, and remaining SYMPTOM-FREE without the aid of medication.

****NOTE: If you are FULLY VACCINATED, upon your return you MUST quarantine 7 days - on Day 3 to 5 may obtain a Negative COVID-19 test for immediate return****
